In celebration of Earth Day this month, we urge you to consider ways that you can help clean up our neighborhood. Once again, the M.A.C.C. is sponsoring a community litter clean up on April 21st—and we certainly invite you join your neighbors for that big event. But there are other small ways that you can make a difference every day.

Now that spring has sprung, maybe you will consider *Redding Up* the alley behind your property that was neglected during the winter. Remember that the city now picks up two bulk items with the regular weekly trash collection.

Did you know that St. Raphael's now has *paper retriever* in its back lot? You can drop off newspaper, magazines, catalogues, mail, envelopes, folders, colored paper, shredded paper in a bag, and gift wrap; proceeds of the recycling effort benefit the school. (While phone books are not accepted in the St. Raphael's paper retrievers, there is a phone book recycling dumpster nearby in the Home Depot parking lot.) The St. Raphael's parish office also accepts eyeglasses, cell phones, and empty ink cartridges for recycling. You can clean out your office while supporting a major organization in our community.

Beginning May 1st, you can drop off broken or unwanted appliances at The Appliance Warehouse on the South Side for free. They will also arrange pick-up for a small fee. More details in next month's Morningside news. If we all pitch in to do one thing, imagine the difference we can make!

"PA ONE CALL" MOVING TO "8-1-1"

Electric, natural gas, telephone, water and cable television lines frequently are buried underground. Starting in **April 2007**, those involved in a project that requires digging will be able to contact the "PA One Call" notification system by dialing "8-1-1," instead of the current toll-free number, 1-800-242-1776, which will remain in effect until April.

State law requires that residents, contractors and excavators call at least 3 business days before digging. On the 3rd business day, you'll receive a message that there are no lines nearby, or that lines have been marked with colored flags or paint on the ground.

CONTRACTOR SEASON BEGINS SOON

We encourage you to do your homework before allowing anyone to work on your home. You can avoid costly mistakes by first checking with the state Bureau of Consumer Protection (1-800-441-2555) or the Better Business Bureau @ 412-456-2700. You'll find that most contractors are reputable and talented. Watch for these signs to avoid unscrupulous contractors:

- A contractor who comes to your door to point out a problem, has materials left over from another job or just happens to be in the neighborhood.
- Be aware of high pressure sales with a special "today only" or "limited pricing."
- Avoid anyone without a business card, local phone number and address.

Drop by their business to check it out and work with only those who you directly contact for a bid. Once you make a decision to contract, be sure that the contract includes all work to be performed, materials, warranties, payments and debris removal. When completely satisfied with the work, and not before, promptly make the final payment on the contract. We wish you all the best on your *Spring Home Improvements*.

“Visitability” and Age-in-Place Remodeling

What if you or one of your family members were no longer ambulatory? Could you continue to live in your house? Would you be able to get up and down those stairs and into and out of the tub or shower? These are some of the questions your designer or contractor should be asking when building or remodeling your home, and the ones trained Certified Age-In-Place Specialists (CAPS) do ask. This program by the National Association of Home Builders (NAHB) teaches its graduates to design with the future in mind, allowing owners to live in their homes longer by making them more accessible to themselves, friends and family. This could prolong or eliminate a move to a more accessible home or to a care home. It’s about keeping your friends and family close, and in a familiar environment.

Remodeling projects are perfect opportunities to improve the accessibility in and to your home. One of the first steps is designing a home so that all necessary rooms are on the first floor. This allows you to live longer in your own home or during a temporary or permanent disability. It may mean adding a bathroom to the first floor, including no-curb or low-curb showers, backing for grab bars and cabinets allowing greater access. Easy access to light switches and greater amounts of lighting can also make a big difference.

Visitability means anyone could access your home’s first floor with an accessible bathroom, even if they have a disability. New laws being written today would make this a requirement for all new construction and many major

remodeling projects. So, as you consider your next remodeling project, keep in mind who might be visiting your home.

As we age our circulation becomes more restrictive and we are less active therefore we feel colder in winter and need more cooling in summer. Improvement to the house’s envelope (insulation, windows, doors) and the heating, ventilation and cooling (HVAC) systems will not only increase your comfort it will reduce your utility bills. If the HVAC system is integrated with improvement to the envelope, you will need a much smaller heating and cooling system and more ventilation, because the envelope has been sealed up. A way to compound your investment is through the use of radiant heating. This is the most efficient and most comfortable type of heating and will allow you to tear up the carpet and refinish your hardwood floors now that you will have warm floors. This also allows better access as carpets are difficult for those in walkers and wheelchairs.

All of this can be built without looking institutional even if you don’t need it today. You can have it all; style comfort and convenience in an age-in-place home.
